***Re: Kentucky Chambers of Commerce Supporting Pre-K for All***

Dear Senators and Representatives:

As Presidents and CEOs from chambers of commerce across the Commonwealth, we urge your support for the Pre-K for All initiative. It would expand Kentucky's voluntary publicly-funded preschool program, so every Kentucky four-year-old has an opportunity at a strong start and parents have an opportunity to return to the workforce.

We know early childhood education is critical to preparing children for a successful career. We also know it would provide financial relief to families, boost our local economies, increase workforce participation, and be a major investment in Kentucky's long-term competitiveness.

American families are struggling to pay the bills and lack of childcare is a major reason. Pre-K for All can help families save money and boost household earnings by nearly \$9,000 dollars each year for at least six years. That's \$54,000 more dollars in a family's pocket, flowing through local economies, creating and maintaining jobs, and growing businesses like the ones we represent.

We've heard it from parents, teachers, community leaders, and business owners: **Pre-K works.** But right now, only 14,000 of Kentucky's 54,000 four-year-olds have access to it.

The research is overwhelming and success is undeniable. Pre-K improves kindergarten readiness, boosts high school graduation rates, and raises overall lifetime earnings. When parents have access to affordable Pre-K, they can work. When parents save thousands on childcare costs, they have more money to spend at our local businesses – supporting our members. In a state where nearly two-thirds of counties lack sufficient childcare, **Pre-K is not just about education—it's an economic development investment that will keep Kentucky moving forward.**

Here's what the data tells us:

- **Improves Kindergarten Readiness:** Over half – 53.8% – of Kentucky's children arrive at kindergarten already behind. Pre-K for All would close this gap and make sure every Kentucky child has a strong start.
- **Increases Workforce Participation:** Up to 70,000 Kentuckians are unable to work because they lack childcare. Pre-K for All will let parents reenter the workforce and take advantage of local job opportunities in our cities and towns across Kentucky.
- **Raises Household Incomes:** A long-term study shows that families with access to Pre-K earn nearly **\$9,000 more per year** – gains that persist for years after their child completes Pre-K.

- **Delivers a 10:1 Return on Investment:** Every dollar invested in Pre-K yields ten dollars in return – from better jobs and health outcomes to reduced criminal justice costs and increased educational attainment.
- **Creates Jobs in Education:** Pre-K for All will generate demand for educators and support staff across the state, creating new careers, and helping attract talent to our towns and cities.
- **Expands Access Across Kentucky:** With 79 of Kentucky's 120 counties having little to no childcare available, this initiative will expand access, create job opportunities, give parents a choice, and lay the foundation for academic success.

As chambers of commerce, we are committed to the success of Kentucky business, helping children thrive, attracting and retaining talent, and building a more competitive workforce for the future.

Our families and local businesses cannot wait. We urge the General Assembly to make expanding Pre-K access for all Kentucky four-year-olds a top priority in the 2026 Budget Session. Together, we can build a stronger, more competitive Kentucky with Pre-K for All.

Thank you for your attention to this critical issue. We stand ready to support this effort and work together for a stronger, more competitive Kentucky.

**Resolutions Adopted, August 20, 2025, by the Danville-Boyle County Development Corporation Related to Early Childhood Education, Childcare, and Pre-K Funding for Public School**

Context for Request

In the June 25, 2025, monthly meeting of the Workforce Development Committee, members of that Committee discussed the closing of the Jennie Rogers Early Learning Center, and its effects on area families, our local workforce, and current and potential new employers. In light of years of looking at the unequivocal importance of quality childcare and preschool education for all children to be Kindergarten-ready, members voted unanimously to request that the DBCDC Board of Directors pass a resolution of strong support for a community early childhood education center to be operated at the Jennie Rogers property. Furthermore, members requested that the Board of Directors include in the resolution the Board's support and advocacy for adequate and sustained funding for Universal Pre-K in the public schools in Danville and Boyle County and across the Commonwealth of Kentucky.

**First Resolution: In Support of a Community Early Childhood Education Center at the Jennie Rogers Property**

**WHEREAS**, during the June 25, 2025, monthly meeting of the Workforce Development Committee, members discussed the impending closure of the Jennie Rogers Early Learning Center and its anticipated effects on local families, the regional workforce, and both current and prospective employers in the Danville-Boyle County area; and

**WHEREAS**, the availability of affordable, quality childcare and preschool education is a vital component of workforce stability and economic development in the community; and

**WHEREAS**, members of the Workforce Development Committee voted unanimously to advocate for continued early childhood education opportunities to be maintained at the Jennie Rogers property; and

**WHEREAS**, the Board of Directors sees the economic efficiency of the community's utilizing a facility and space that is centrally located and recently renovated specifically to provide childcare and early education services, all in partnership with local government.

**NOW, THEREFORE, BE IT RESOLVED**, that the Danville-Boyle County Development Corporation (DBCDC) Board of Directors expresses its strong support for the establishment and operation of a community early childhood education center at the Jennie Rogers property; and

**BE IT FINALLY RESOLVED**, that the DBCDC Board of Directors will work in partnership with local and state leaders, educational institutions, families, and employers to champion equitable access to high-quality early learning opportunities as a foundation for a stronger, more resilient community and workforce.
