b. Presentation: "State of the Commonwealth" Part II: Kentucky Early Childhood Landscape and Funding Streams

Ms. Baker, Ms. Turley, and Ms. Day followed up on data requests from the previous meeting and provided an overview of the number of children enrolled in state-funded public preschool, Head Start, and Child Care Assistance Program (CCAP).



Ms. Baker, Ms. Turley, and Ms. Day gave a presentation on Kentucky's early childhood landscape and funding streams. They discussed the structure of the early childhood system and the funding streams that support the early childhood programs that serve Kentucky's 4-year-olds. They also discussed the results seen in respect to the current early childhood system in the Commonwealth.
